Premium quote for optional benefits may be submitted in a separate closed envelope duly superscribing it as " <u>Premium quote for optional benefits</u> ". But the same shall not be considered for the award of tender. The submission of quote for optional benefits is not mandatory. The L1 (lowest) bid will be determined based on the premium quote for mandatory benefit only.
